**Memorandum of Understanding
on Cultural, Educational and Scientific Cooperation
between
The University of Jordan
and
The University of Ferrara**

In accordance with a mutual desire to promote further cooperation between Jordan and Italy, The University of Jordan and the University of Ferrara join in the following Memorandum of Understanding (MoU) on cultural, educational and scientific cooperation.

Both Universities will encourage direct contact and cooperation between their faculty members, departments, institutes and other research centers subject to the provisions of this MoU, and will act as coordinators of contacts with other institutions as appropriate.

The University of Jordan and the University of Ferrara shall cooperate in the fields of teaching and research listed below: Anthropology, Archaeology, Archaeozoology, Prehistory, Protohistory, Quaternary, Palaeontology, Cultural Heritage. Cooperation in further areas may be arranged by mutual agreement.

Within the fields specified, both universities agree to the following forms of cooperation:

- Joint research activities.
- Exchange of invitations to scholars for lectures, talks, and sharing of experience.
- Exchange of invitations to scholars to participate in conferences, colloquia, symposia.
- Exchange of information in fields of interest to both universities.
- Exchange of faculty members and post-doctoral fellows for teaching and research.
- Exchange of graduate and undergraduate students for study and research. The exchange students shall pay normal tuition and fees to their home institution, in accordance with that institution's policies. Neither institute shall assess charges upon the other or upon its students for tuition or fees. The exchange students shall provide for their own room and board, books, transportation, student health insurance fees and medical care, passports, visas and personal expenses either through personal funds or through grants.

Themes of joint activities and the conditions for utilizing the results achieved and arrangements for specific visits, exchanges and other forms of cooperation not explicitly referred to in this MoU will be negotiated for each specific case.

Both universities understand that all financial arrangements will have to be negotiated and will depend on the availability of funds.

This MoU is valid for a period of four years commencing on the date signed by the last party, and may be renewed after being reviewed and renegotiated by both parties. This MoU may, at any time during its period of validity, be terminated by one of the parties upon written notice to the other party not later than six months before the termination date. The termination will not affect ongoing activities.
